During the financial year ended 31 March 2022, this authority's internal auditor acting independently and on the basis of an assessment of risk, carried out a selective assessment of compliance with the relevant procedures and controls in operation and obtained appropriate evidence from the authority.

The internal audit for 2021/22 has been carried out in accordance with this authority's needs and planned coverage. On the basis of the findings in the areas examined, the internal audit conclusions are summarised in this table. ## **Explanatory Note Regarding Internal Control Objective B on the Annual Internal Audit Report 2022**

The Internal Auditor recorded Objective B as not being met. This is solely because Aylesbeare Parish Council did not have published financial regulations.

To correct this the NALC model Regulations were downloaded and Cllr Cooke CeMAP CeRER was asked to inspect them and confirm their appropriateness for the Parish Council (Annual General Meeting, May 2022, para 7 page 2 2022-05 refers). Cllr Cooke has confirmed they are suitable but was been unable to attend June's meeting.

The Council intend formally adopt the regulations at the next meeting in July 2022.

The draft regulations, as approved by Cllr Cooke, are published on Aylesbeare Parish Council's website.
